Project Description

Built in 1908, the Borden Creamery Building in Mount Pleasant, Michigan had sat vacant for 40 years. In 2003, Central Michigan Developers LLC of Midland saw potential in the decaying building and its site. They negotiated an option to purchase agreement with the Mount Pleasant Economic Development Corporation. When the city of Mount Pleasant agreed to move city offices into a portion of the building upon completion, the project's success was ensured. Being a nationally registered historic landmark building, the rehabilitation would require strict attention to detail. The appearance of the original single pane double hung windows had to be duplicated exactly.

Unique Requirements/Solutions

Obtaining the exact field measurements and the recreation of the muntins was extremely challenging. Each window design was required to pass strict federal guidelines. In addition, the rehabilitation of the 40,000-square-foot building required substantial environmental cleanup, including the removal of significant amounts of lead and asbestos. The cleanup and the historic rehabilitation transformed the west end of the downtown area.
